Sir,

This has reference to your complaint made to Chairman, NHAI cited under ref. above regarding toll collection. In this regard, a detailed Report is furnished as below:-

2. The work of 4-laning between Dhule to Pimpalgaon (Km 265.00 to Km 380.00) section of NH-3 has been completed under BOT (Toll) basis and BOT Concessionaire is collecting the toll for the Project Highway. The two toll plazas, namely, (i) Laling, Tal./Dist Dhule, Km 268.600 and (ii) Chandwad, Km 356.700 have been established to collect toll for this section as per Notification No. S. O. 2405 (E), Dtd. 18.009.2009 published in Gazette, Govt. of India. The Concessionaire is authorized to collect and retain the fees for the use of the said section. As per para 5 of the said Notification, "**Vehicle passing through any of the fee plazas are required to pay the specified fee for the entire project stretch from Km 265.00 to Km 380.00 at the first plaza encountered and shall be allowed to cross second plaza by showing the receipt.**" A copy of above Gazette Notification is attached herewith for your information please.
