#### Circular No. NHAI/CO/4/2016

Sub.: Arriving user fee on ODC/ OWC on National Highways.

MoRTH has been receiving representations from Hydraulic Trailer Owner's Association (HTOA) on the issue of alleged harassment of Hydraulic Trailer Operators at the toll plazas. To discuss the representations, a meeting was held on 03.02.2016 at MoRTH and the minutes of meeting have been received vide MoRTH OM dated 04.02.2016 (copy enclosed).

2. It has been decided that the user fee shall be levied independently on every unit according to the category of the puller trailer and attached Modular Hydraulic Trailers as per RCs. This decision may be strictly complied with for arriving at the total fee payable at the toll plaza in case of ODC/ OWC vehicles.

This Circular shall be applicable on all the Toll Plazas (NHAI as well as Concessionaires).

# Minutes of the meeting held with Hydraulic Trailer Owner's Association on 3/2/2016

A meeting under the Chairmanship of Director(Toll) was held on 3/2/2016 to discuss the representation made by Hydraulic Trailer Owner's Association(HTOA) to Secy.(RT&H) on 22/12/2015 regarding categorization of Hydraulic Trailer in NH Fee Rules and stop harassment of Hydraulic Trailers Operators at fee plazas. List of participants is annexed.

- 2. Representatives of the Association have informed that modular Hydraulic Trailers and puller tractor are independent units and registered independently. Specific Hydraulic Trailer is formed by attaching modular Hydraulic trailer with puller tractor depending upon the load/consignment. Therefore, fee to be levied independently on every unit according to the category of vehicle as per RC. Total fee to be paid at the plaza may be arrived by adding the fee payable by every unit. This was agreed by the GM(CO),NHAI. It was also clarified that fee paid at the time of taking permission has no bearing/relation with the user fee payable.
- 3. Regarding categorization of Hydraulic Trailer as separate category with the fee rule the association may submit a detail proposal, if felt necessary.
