- I confirmed that the rates on display boards at the Toll Plaza (responsibility of NHAI) and the rates levied on the road users are as per rates validated vide CO Division letter no.70709 dt.24.08.2015
- 2. I confirm that the Contractor is issuing Return Journey Pass, 30 days Pass, Local Vehicle Pass (non-commercial) & District Pass to all eligible users, his methodology is simple and he is not harassing the road users in this regard.
- I have examined the performance of the Contractor w.r.t various provisions in the Contract Agreement <a href="23.01.2008">23.01.2008</a> and confirm that the Contractor is meeting his obligations. I confirm the levy of the following penalties on the contractor.
