Actually dated 28.09.2014 Around 11.30 PM i went to Dongargadh for devi darshan (Navratri is running)after the puja will return with my friend by Byke on dated 29.09.2014 at the time of returning(Durg Time 7.50 AM around) i had seen new road & due to huge traffic also in existing NH we have moved the new raod side & running continuously,when i reached the destination of Toll plaza Security Guard & Mr Vinod,Officer of that Toll plaza was their & they are demanding the toll forcefully for two wheeler i requested to both of them but they called his another staff around 6-7 person for the same & creating pressure for paying toll of Rs 14 for the same & they are telling without toll paying u were not cross the area i.e its type of habit is indicate bad manner/behavior, even then i had requested to all concern because i had never seen inside the hole India any toll plaza has taken toll for two wheelers that was embarrassing& shocking situation of the my life because i had visited more then 10-12 states for personnel & official works but this type of toll collection for two wheeler i had never seen never heard also.

So I personally requested to you please look into the matter & provide your full co-operation for the same for future.i.e. instruct to him for close the taking of Toll for Two Wheeler's with immediate effect & take the corrective measure action also for the same please sir.
