NOTIFICATIONS UNDER THE INDIAN TOLLS ACT, 1851.

[G.O. Ms. No. 165, Highways and Minor Ports (HV2), 1st October 2018, (M.S. No. 15, 2018), (Purattasi 15, Vilambi, Thiruvalluvar Aandu - 2049)]

No. TN2/HTM/555/2018

In exercise of the powers conferred by clause (c) of sub-section (1) read with clause (c) of sub-section (2) of section 2 of the Indian Tolls Act, 1851 (Central Act VIII of 1851), the Governor of Tamil Nadu hereby levies tolls for a completed length of 20.333 Km for the passage of motor vehicles on the section of the Ennore - Manali Road Improvement Project connecting the Chennai and Ennore Ports via Inner Ring Road at Madavaram junction (Km 17+500) and Thiruvalluvar-Ponner-Pancheti Road (Km 13+500) Manali Oil Refinery Road junction (Km 5+600) Ennore Expressway (Km 0+000) at Port gate No. 0, improved and maintained on a long term basis by Chennai Ennore Port road company Limited (CEPRL) or any agency appointed / authorised by CEPRL to collect the user fee at the rates specified in the schedule appended to this notification for the period upto recovery of the project capital cost of Rs 600 crores and after recovery of the project capital cost, the tolls levy shall be reduced to 40% of the rates. The user - fee rates shall be revised annually w.e.f. 1st April by increasing the base rate at three per cent without compounding in addition to increase / decrease of Wholesale Price Index (WPI) for the month of December of the immediately preceding year in which such revision is undertaken.

2. This notification shall come into force with effect on and from the 06th October 2018.

## NOTIFICATION-II

(G.O (Ms) No.166, Highways and Minor Ports (HV2) Department, dated 1st October 2018)

In exercise of the powers conferred by clause (b) of section 4 of the Indian Tolls Act, 1851 (Central Act VIII of 1851), the Governor of Tamil Nadu hereby specifies that no tolls shall be paid by the following classes of motor vehicles for the use of the passage on the section of the Ennore - Manali Road Improvement Project connecting the Chennai and Ennore Ports with Inner Ring Road at Madayaram Junction (Km 17+500) and Thruvottiyur-Ponner-Panchetli Road (Km 13+500) Manali Oil Refinery Road Junction: (Km 5+000) Ennore Expressway (Km 0+000) at Port gate No. 0.

(a) Motor vehicles transporting and accompanying:

The President of India;

The Vice-President of India; The Prime Minister of India;

The Governor of a State;

The Chief Justice of India;

The Speaker of the House of People;

The Cabinet Minister of the Union;

The Chief Minister of a State;

The Judge of the Supreme Court;

The Lieutenant Governor of a Union Territory;

The Ministry of Defence including those which are eligible for exemption in accordance with the provisions of the Indian Toll (Army and Air Force) Act, 1901 and rules made there under, as extended to Navy also;

➤ The Central and State armed forces in uniform including para military forces and Police;

An executive Magistrate;

The fire-fighting Department or Organization;

The National Highway Authority of India or any other Government organization using such vehicles for inspection, survey, construction or operation of National Highways and maintenance thereof;

➤ Motor Vehicles used as ambulance;

Motor Vehicles used as funeral van;

Motor Vehicles owned for personal use by bonafide local residents living along the project road; and

Mechanical vehicle specially designed and constructed for the use of a person suffering from physical defect or disability.
