Now, NHAI HQ vide letter dated 30.05.2024 has issued direction for the revised user fee rates for FY 2024-25 for NH fee plazas shall be effective w.e.f. 03.06.2024 (00:00 Hrs.), in accordance with the applicable NH Fee rules 2008, after publication in newspapers as per Rule 12, only on 02.06.2024 & not before 02.06.2024 in compliance of ECI directions.
