- 2. The rate of Monthly Pass for local non-commercial vehicles residing within a distance of 20 Km from each Toll Plazas is Rs. 340.00 for the year 2024-25, which is subject to revision every year as per the provisions of the National Highways Fee (Determination of Rates and collection) Rules, 2008. This office vide letter dated 27.03.2024 requested to publish the public notice.
- 3. NHAI HQ, Web-admin email dated 01.04.2024 has issued direction to maintain status quo in respect of user fee rates i.e. to continue with the user fee rates prevalent for FY 2023-24 (without revision) at NH fee plazas till date of polls which was circulated to all toll agency vide this office letter dated 01.04.2024 for compliance of ECI directions.
- 4. Now, NHAI HQ vide letter dated 30.05.2024 has issued direction for the revised user fee rates for FY 2024-25 for NH fee plazas shall be effective w.e.f. 03.06.2024 (00:00 Hrs.), in accordance with the applicable NH Fee rules 2008, after publication in newspapers as per Rule 12, only on 02.06.2074 & not before 02.06.2024 in compliance of ECI directions.

In view above, all stake holders are requested to kindly update the user fee rates in toll plaza software, ETC infrastructure and bank portal which is applicable w.e.f. 03.06.2024 at 00:00 Hrs. Toll Collection agency shall have the responsibility to get it updated from System Integrator and display boards at the toll plazas as per contract agreement.


