- 2. *Rate of monthly pass for a person who owns a mechanical vehicle registered for Non-Commercial purposes and resides in within a distance of twenty Kilometers from the Toll Plazas is Rs. 265.00 (Rupees Two Hundred and Sixty Five only) for the year 2019-20.
- 3. For the column vide which the Fee for monthly pass is conveyed it is clarified that as per clause 27.5.2 of concession agreement, the concessionaire shall upon request from any person for issue of fifty or more one way Toll tickets, issue such tickets at a discounted rate equivalent to two thirds of the fee payable for the respective vehicle. Such discounted tickets shall entitle the specified vehicle to commute on the Project Highway by using one ticket for single one-way trip at any time during a period of the one month from the date of payment of fee. Necessary action may please be taken accordingly.
- 4. Detailed calculation sheet is enclosed as Annexure I & II, so that, the above rates may be rechecked at your end before implementation.
- 5. PD PIU Solapur may ensure that the above approved user fee rates may be conveyed to the concessionaire for completed length considered in the calculation of user fee rates. PD may ensure updation of rates for ETC transactions also.
- 6. It is requested to take action for wide Publicity of revised fee rate before its implementation.
