As per the NHAI Policy Guidelines cited 9th above, RO NHAI has been delegated for approval of proposals of validation (initial fixation)/revision of user fee rates for Public Funded/BOT/OMT/BOT(Annuity)/Hybrid Annuity/ToT Projects.

- 2. The provisional of fee rules have been considered for Revision of User Fee for the year 2019-20 as per the Published Fee Notification vide letter cited 7th above.
- 3. The Linking factor due to change of base year of WPI from 2004-05 to 2011-12 vide letter cited 8th above, have been considered for Revision of User Fee for the year 2019-20.
- 4. The PD, PIU-Hospet vide letter cited 1&3 above, submitted the Revision of User fee for the year 2019-20 as proposed by the Concessionaire and recommended by the Consultant.
- 5. As per your recommendation, Competent Authority has accorded approval for Revision of User Fee for the year 2019-20 of above mentioned section to be applicable w.e.f. 01.04.2019 to 31.03.2020 are as detailed below:

6. The rates for monthly pass for local personal vehicle shall be Rs.265/- for the year 2019-20. Subject to the following Conditions.

i. PD will recheck the calculation before implementation. In case any discrepancy is found same shall be informed to this office for examination and issue amendment if any required.

ii. PD will confirm after its implementation and forward a copy of advertisement issued by the concessionaire for commencement of revised user fee to this office.

- It is also brought out that MORTH vide letter dt. 07.03.2019 cited 10 above, has brought out and prescribed guidelines / standard Operating procedure (SoP) for iii. Toll Notifications and mandatory ETC infrastructure in all toll lanes. Hence the same shall be examined for its applicability wherever required.
- 7. It is further to clarify that as per user fee notification, the Concessionaire shall issue 50 or more one way tickets at a discounted rate equivalent to 2/3rd of the fee payable during the period of one month from the date of payment of fee. If any person asks more than 50 trips during a period of one month, the concessionaire shall be required to issue such tickets at a discounted rate as above (i.e. if 60 trips are asked in a month by any person for a car, the amount is (i) Vanagiri & Shahapur 60x49.79x2÷3=1991.6= 1990/-(Rounded) and (iii) Hitnal $60x39.7211x2 \div 3 = 1588.844 = 1590$ /- (Rounded).
- Detailed calculation sheet is also enclosed herewith, so that, the above rates may be rechecked at your end before implementation. In case, any discrepancy is found, the same may immediately be informed to RO, NHAI Bengaluru.

Please confirm after its implantation and copy of advertisement for commencement of revised user fee may also be provided to RO, NHAI Bengaluru.
