Sir,

As per the NHAI Policy Guidelines cited 9th above, RO NHAI has been delegated for approval of proposals of validation (initial fixation)/revision of user fee rates for Public Funded/BOT/OMT/BOT(Annuity)/Hybrid Annuity/ToT Projects.

- 2. The provisional of fee rules have been considered for Revision of User Fee for the year 2018-19 as per the Published Fee Notification vide letter cited 6th above.
- 3. The Linking factor due to change of base year of WPI from 2004-05 to 2011-12 vide letter cited 4th above, have been considered for Revision of User Fee for the year 2019-20.

- 4. The User-Fee is calculated based on modified W.P.I. for December 2018 i.e., 119.7 instead of 120.1.
- 5. The PD, PIU-Hassan vide letter cited 1st above, submitted the Revised Revision of User fee for the year 2019-20 as proposed by the Concessionaire and recommended by the Independent Engineer.
- 6. This office vide letter cited 4th above had conveyed approval of Competent Authority for Revision of User Fee Collection with effect from 01.04.2019 taking W.P.I for December 2018 as 120.1.
- 7. Now as per the recommendation of PD Hassan and IE the revised user fee rates as per updated WPI for Dec-2018 is calculated for both toll plazas at Km 119.100 of Kirisave Village and Km 169.350 of Shanthigrama Village for the year 2019-20 of above mentioned section to be applicable w.e.f. 01.04.2019 to 31.03.2020 are as detailed below:
 - (i) **Toll Plaza at Km 119.100 Kirisave Village** (Design Chainage Km 116.790) Total length of 41.140 Km (Four-lane length=31.993 Km and Two-lane length=9.147 Km)

- 8. The rate of monthly pass for local non-commercial vehicles residing within a distance of 20 Km from toll plaza for the FY 2019-20 shall be $\bf Rs.~265.00$
- 9. It is further to clarify that as per user fee notification, the concessionaire shall issue **50 or more one way tickets** at a discounted rate equivalent to 2/3rd of the fee payable during the period of one month from the date of payment of fee. The amount indicated above is for monthly pass for 50 one way trips. However, if any person asks more than 50 trips during a period of one month, the concessionaire shall be required to issue such tickets at a discounted rate as above [i.e. if 60 trips are asked in a month by any person for a car, the amount is (i) Kirisave: 60x43.322x2÷3=1732.88=1733/-(Rounded) & (ii) Shanthigrama: 60x37.204x2÷3=1488.16= 1488/- (Rounded). Necessary action may please be taken accordingly.

- 10. MORTH vide letter dated: 07.03.2019 cited 11^{th} above has brought out and prescribed guidelines/standard Operating procedure (SOP) for Toll Notifications and mandatory ETC infrastructure in all toll lanes. Hence the same shall be examined for its applicability wherever required.
- 11. It is further requested to verify the completed lengths/lengths handed over to Concessionaire vis-à-vis those considered in rates calculations and then send the approved rates to Concessionaire.
- 12. Detailed calculation sheet is also enclosed herewith, so that, the above rates may be rechecked at your end before implementation. In case, any discrepancy is found, the same may immediately be informed to RO, NHAI Bengaluru.
- 13. Please confirm after its implantation and copy of advertisement for commencement of revised user fee may also be provided to RO, NHAI Bengaluru.
