Sir,

Kind attention to above subject matter, the Competent Authority, NHAI, RO-Odisha has approved vide E-Office No. 244495, dated 24.03.2025 the revised user fee rate for Bhubaneswar-Puri of NH-316 which is to be applicable w.e.f. 01.04.2025 to 31.03.2026. The details of revision of User Fee Rate for the FY 2025-26 are as follows:

It is further to clarify that as per user fee notification, the concessionaire shall issue 50 or more one way tickets at a discounted rate equivalent to $2/3^{rd}$ of the fee payable during the period of one month from the date of payment of fee. If any person asks more than 50 trips during a period of one month the concessionaire shall be required to issue such tickets at a discounted rate as above (i.e. if 60 trips are asked in a month by any person for a car the amount will be $\{60 \text{ X pre-rounded fee for single trip X 2/3 rounded to nearest 5 rupees}\}$.

In view of the above, it is requested to take necessary action & necessary changes of user fee rate may please be made accordingly & also display in informatory Board. The necessary paper publication will be done by the NHAI on 31.03.2025. A confirmation in this regard may please be communicated to this office for reference & record.
