Sir,

Kind attention to above subject matter, the Competent Authority has approved vide E-Office No. 244493, dated 24.03.2025 the revised user fee rate for Bhubaneswar-Jagatpur-Chandikhol of NH-16 which is to be applicable w.e.f. 01.04.2025 to 31.03.2026. The details of revision of User Fee Rate for the FY 2025-26 are as follows:



It is further to clarify that as per user fee notification, the concessionaire shall issue 50 or more one way tickets at a discounted rate equivalent to 2/3<sup>rd</sup> of the fee payable during the period of one month from the date of payment of fee. If any person asks more than 50 trips during a period of one month the concessionaire shall be required to issue such tickets at a discounted rate as above (i.e. if 60 trips are asked in a month by any person for a car the amount will be {60 X pre-rounded fee for single trip X 2/3 rounded to nearest 5 rupees}.

In view of the above, it is requested to take necessary action for publication of the revision of user fee at least one newspaper, each in English and vernacular language, having

a wide circulation in such area & necessary changes of user fee rate may please be made accordingly. A confirmation in this regard may please be communicated to this office for reference & record.
