Kharik Toll Plaza at Km. 333.150 for the section from Km 270.00 - Km 410.000 (Khagaria – Purnea) of National Highway No. 31 in the State of Bihar 2 Lane with Paved Shoulder (under Fee Rules 2008 as Amended). The user fee notification published vide SO No. 82(E) Dated 10.01.2014.


2. The User fee rates for 2019-20 have been calculated based on following details:
