
Competent Authority, NHAI approved revised user fees for the period of 01.04.2019 to 31.03.2020 are as under:

The rates for monthly passes applicable for local personal vehicle shall be Rs. 265/for the year 2019-20.

It is further to clarify that as per user fee notification, the Concessionaire shall issue 50 or more one way tickets at a discounted rate equivalent to 2/3rd of the fee payable during the period of one monthly from the date of payment of fee. The amount indicated above is for monthly pass is for 50 trips. However, if any person asks more than 50 trips during a period of one month, the Concessionaire shall be required to



issue such tickets at a discount rate as above (i.e. 60 trips are asked in a month by any person for a car, the amount is 60x103.55 (pre-rounded fee for single trip) x2/3= 4142 rounded to Rs. 4,140/-. The necessary action may please be taken accordingly.

It is requested to take action for wide publicity for revised fee rate before its implementation. Copy of calculation sheet is also enclosed for verification and informing discrepancy, if any, before implementation.
