The rate for monthly pass applicable for local non commercial personal vehicle shall be Rs.265/-, for the F.Y. 2019-20 for all the three Toll plazas.

It is further to clarify that as per user fee notification, the Concessionaire shall issue 50 or more one way tickets at a discounted rate equivalent to 2/3rd of the fee payable during the period of one month from the date of payment of fee. The amount indicated above for monthly pass for 50 trips. However, if any person asks more than 50 trips during a period of one month, the Concessionaire shall be required to issue such tickets at a discounted rate as above (i.e. if 60 trips are asked in a month by any person for a car (in case of Nannoor toll plaza), the amount is 60×69.17 (pre-rounded fee for single trip) $\times 2/3 = 2,766.80$ rounded to Rs.2,765/-]. Necessary action may please be taken accordingly.

Detailed calculation sheets are also enclosed herewith, so that, the above rates may be rechecked at your end before implementation. In case, any discrepancy is found, the same may immediately be informed to CO Division at NHAI, HQ.
