This is with reference to letter cited (2) above wherein, the Independent Engineer was requested to comments on revision of user-fee from; 01.09.2018 to 31.08.2019, which was provided by letter cited (3) above.

2. Based on the request of the Concessionaire and recommendations of the Independent Engineer the proposal was submitted, vide PIU letter cited (4) above, to Regional Office for the approval of Competent Authority for revision of user-fee from 01.09.2018 to 31.08.2019.

3. The approval for revision of user fee 2018-19 has been communicated vide RO, Bengaluru letter cited (5) above (copy enclosed) subject to condition indicated in the letter. Hence it is hereby conveyed to implement the revision of user-fee as below:

3.1 Stipulations on number of pass the vehicle does, as per Schedule-G of Concession Agreement will apply i.e., (i) when the same vehicle has to cross the said stretch of the National Highway more than once in a day, the user shall have the option to pay the fee for multiple trips at 1.5 times the rates while crossing the toll plaza in the first trip itself, (ii) If the vehicle has to use the said stretch continuously and frequently for entire month, the vehicle owner can have a monthly pass on payment of charges equal to thirty (30) times rate applicable for single trip, (iii) number trips against a monthly pass shall be restricted to sixty (60) trips in a month.

3.2 It is requested to verify the complete length/lengths handed over to the Concessionaire vis-à-vis those considered in rates calculation and if found correct the user-fee before implementation under intimation to PIU and Regional Office of NHAI.

3.4 Detailed calculation sheet is enclosed with this, so that the approved rates may be rechecked at your end before implementation under intimation to PIU.

3.5 Please confirm after the commencement of revised fee and copy of advertisement for commencement of revised fee may be provided in four sets.


