Sirs,

This is in reference to the instructions issued vide letter cited under Ref.(ii), to continue the status quo in respect of User Fee rates prevalent for F.Y. 2023-24 (without revision) at National Highway Fee Plazas be continued till last date of poll i.e. 01.06.2024, keeping in view of the directions received from MoRTH.

2. Further, the Rule no.12 of National Highways Fee (Determination of Rates and Collection) Rules, 2008 further states as under:

**"Display of information. - (1) The executing authority of the concessionaire, as the case may be, shall publish a notice specifying the amount of fee to be charged from the mechanical vehicle, in at least one newspaper, each in English and vernacular language, having a wide circulation in such area."**

3. In view of above, the revised User Fee rates for F.Y.2024-25 for National Highway Fee Plazas shall be effective w.e.f. 03.06.2024 (00:00 Hrs.), in accordance with the applicable National Highways Fee Rules, after publication in newspapers as per Rule 12 mentioned above, only on 02.06.2024 and not before 02.06.2024 in compliance of ECI directions.


