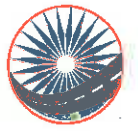

2. It is clarified that the fee collecting agency shall upon request from any person for issue of 50 (fifty) or more one-way toll tickets, issue such tickets at a discounted rate equivalent to two thirds of the fee payable for the respective vehicle, such discounted tickets shall entitle the specified vehicle to commute on the Project Highway by using one ticket for single one way trip at any time during a period of the one month from the date of payment of fee. Necessary action may please be taken accordingly.
3. The user fee rate will be affected only after completing necessary procedures as per fee rule notification and NHAI HQ circular issued from time to time.
4. Detailed calculation sheet is enclosed as **Annexure – I**. The above rates may be rechecked at your end before implementation.
5. PD PIU Ahmednagar may ensure that the above approved user fee rates may be conveyed to the fee collecting agency for completed length considered in the calculation of user fee rates. PD may ensure updating of rates for ETC transactions also.
6. It is requested to take action for wide Publicity of revised fee rate before its implementation.
7. This issues with the approval of CGM (Tech)/RO-Mumbai.
