

It is to intimate that as per NHAI HQ email dated 26.03.2024 at ref(ii) Competent Authority of NHAI has approved the Validation of revised User fee rates in respect of Balibhasa Toll Plaza at Km 43.350 in the State of West Bengal to be applicable **w.e.f. 01.04.2024 to 31.03.2025**. Latest Gazette Notification No SO 1503(E) was published on 20.03.2024. Details of revised user fee rates are as under:-

- The rate for monthly pass applicable for Local Non-commercial Vehicle residing within a distance of 20 Km from the Toll Plaza shall be Rs 340/- for the year 2024-2025.
