Please refer your letter no. 2806 dated 14.03.2024 vide which you have submitted the proposal for Revision of user fee rates at Bhagan Fee Plaza w.e.f. 01.04.2024 for FY 2024-25. Accordingly, the same has been verified by the IE of the project vide letter no. 4130 dated 22.03.2024.

2. In this regard, it is intimated that the Competent Authority of NHAI has approved the revised user fee rates for the year 2024-25 to be implemented w.e.f. 01.04.2024 vide e-office Computer No. 244367.

3. The revised user fee rates of Bhagan Fee Plaza are as under:

The rate of monthly pass for a person who owns a mechanical vehicle registered for non-commercial purpose and resides within a distance of twenty kilometers from the toll plaza is Rs. 340.00 (Rupees Three Hundred Forty only) for each fee plaza for the year 2024-25 and is subject to revision every year as per the provision of National Highways Fee (Determination of Rates and Collection) Rules, 2008.

5. In view of the above, it is directed to take necessary action for implementation of the said revised user fee rates w.e.f. 01.04.2024. It is also requested to publish the revised user fee rates in Newspaper and the all expenses of the same will be borne by the Concessionaire.
