It is intimated that the Competent Authority vide Note No. 12 of E-Office File No. 11172/RevisioninTollFee/GhulalandBhagoMajraNH-05/ (Computer No. 123712) 550 has approved the revised user fee rates to be applicable for the Bhago Majra Toll Plaza w.e.f. 01.04.2022 for the FY 2022-2023; which are reproduced as hereunder:-

2. *The user of the vehicle not fitted with Fastag or vehicle without valid or functional Fastag entering into Fastag lane of the toll plaza shall pay a fee equivalent to two times of the fee applicable to that category of vehicles as per Notification no GSR298 dated 15.05.2020*
3. *Rate of Monthly pass for a person who owns mechanical vehicle registered for non-commercial purpose and resides within a distance of twenty kilometers from the fee toll plaza is **Rs. 315/-** (Rupees Three Hundred and Fifteen only) for the year 2022-2023 and subject to revision every year as per the provisions of the National Highways Fee (Determination of Rates and collection) Rule, 2008.*


2. In this regard, the public notice regarding revised toll fee has since been published in the newspapers on 25.03.2022, hence, it is requested to ensure wide publicity of revised fee rates applicable w.e.f. 01.04.2022 and the same should be displayed prominently at Bhago Majra Toll plaza.

3. Further, you are requested to ensure the compliance of the weekly remittances, double payment penalty amount and TCS amount without delay to avoid any penalty as per provisions of Contract Agreement.
