It is intimated that the Competent Authority, the Regional Office Chandigarh has approved the revised user fee rates to be applicable for the **Azizpur toll plaza w.e.f. 01.04.2024** for the **FY 2024-2025**; which are reproduced as hereunder:-

3. *Rate of Monthly pass for a person who owns mechanical vehicle registered for non-commercial purpose and resides within a distance of twenty kilometers from the fee toll plaza is Rs. 340/- (Rupees Three Hundred and Forty only) for the year 2024-2025 and subject to revision every year as per the provisions of the National Highways Fee (Determination of Rates and collection) Rule, 2008.*

2. It is intimated that the public notice regarding revised toll fee has processed for publication in the newspapers; hence, it is requested to ensure wide publicity of revised fee rates at Display Boards installed in toll plaza premises of Azizpur Toll Plaza applicable w.e.f. 01.04.2024 and the same should be displayed prominently at toll plaza.

3. Further, you are requested to ensure the compliance of the weekly remittances, double payment penalty amount and TCS amount without delay to avoid any penalty as per provisions of Contract Agreement. **The revised toll remittance will be conveyed separately in due course of time.**
