Please refer letter ref 4th cited above, wherein, PD, PIU-Hyderabad has requested approval for the implementation of revised User Fee during the Financial Year 2024-25 at **Panthangi, Korlapahad and Chillakallu Toll Plazas** on Hyderabad-Vijayawada section of NH-65.

2. Based on the recommendations of Project Director and F&A Unit at Regional Office, Hyderabad, the approval of Competent Authority for revision of User Fee for the FY 2024-25 of above mentioned subject section to be applicable w.e.f. 01.04.2024 at Panthangi, Korlapahad and Chillakallu Toll Plazas respectively, is hereby communicated as under.

3. The above approval is subject to the following conditions:

- PD shall ensure to recheck the calculations before implementation. In case any discrepancy is found same shall be informed to this office for examination and issue amendment if any required.
- PD shall ensure to confirm after its implementation and forward a copy of advertisement issued by the Concessionaire for commencement of revised user fee to this office.

4. As per user fee notification, the user fee collecting agency/toll contractor shall issue 50 or more "one way tickets" at a discounted rate equivalent to 2/3rd of the fee payable during the period of one month from the date of payment of fee. The amount indicated above for monthly pass for 50 trips. However, if any person asks more than 50 trips during a period of one month, the Toll Contractor shall be required to issue such tickets at a discounted rate as above and necessary action may please be taken accordingly.

5. The rates for monthly passes applicable for a mechanical vehicle registered for non-commercial purpose and residing within a distance of 20 Km from the above toll plaza for the year 2024-25 shall be Rs.340/- subject to revision every year as per the provisions of the 2008 Amended Fee Rules.

6. Detailed calculation sheet is also enclosed herewith, so that, the above rates may be rechecked at your end before implementation. In case, any discrepancy is found, the same may immediately be informed to Regional office, NHAI, Hyderabad.

7. Please confirm after its implementation and copy of advertisement for commencement of revised user fee may also be provided to this office and CO Division at NHAI HQs.
