Sir,

This has reference to Toll Fee Notification dt. 27.12.2019 for the user fee plaza at Chotiya (Ch.117+150) for the use of road stretch of Katghora to Shivnagar section of of NH-130 (Old NH-111) from Km.82.500 to Km.163.400 in the State of Chhattisgarh, wherein under Para-9 stated that, the Toll fee shall be revised annually in accordance with rule-5.

2. In this regard, Competent Authority, RO-Raipur vide e-office (computer no.196709) Note#112 dt.20.03.2024 has approved the Revised User Fee Rates for Chotiya Toll Plaza for the Financial Year 2024-2025 effective from 01.04.2024 to 31.03.2025. The approved Revised Users Fee Rates are as under:

3. The rates for monthly pass applicable for local non-commercial vehicle residing within a distance of 20Km from the toll plaza shall be Rs.340/-

4. Fee for commercial vehicle (excluding vehicles plying under National permit) registered in the district where the fee plaza falls shall be 50% of the specified rate for the category of vehicle provided no service road or alternative road is available for use of such commercial vehicles.

5. As per clause 5(b) of the Contract Agreement, the revised remittance on annual increase of user fee rates due to change in WPI, the contractor shall deposit the revised remittance from

applicable date. Accordingly, it is requested to deposit the revised weekly remittance of Rs.44,40,953/- w.e.f. from 01.04.2024.
