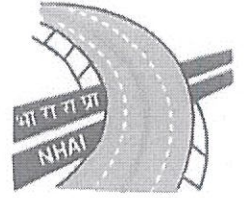

With reference to subject matter and references above, approval for the revised applicable fee for the period of 01.04.2025 to 31.03.2026 for the user fee plaza Deoria on NH-74 (Kashipur -Sitarganj section) for the completed length of 77.200 km. has been accorded by Competent Authority. Competent Authority has approved the revised user fee rates for FY 2025-26 of Deoria Fee Plaza details of which are as below:-

The rates for monthly pass applicable for local non-commercial vehicle residing within a distance of 20 Km from the above fee plaza for F.Y 2025-26 w.e.f. 01.04.2025 shall be Rs. 350/- subject to revision every year as per provision of the NH (Determination of Rates and Collection) Rules 2008 and its amendments. You are requested to publish the above rates in at least 02 newspapers (1 in English & 1 in vernacular i.e. Hindi newspaper) well before implementation of new rates.
