It is to inform that the Competent Authority, NHAI, RO-Raipur vide note dated 22.03.2024 has approved the revised User Fee Rates for Dhank & Chuipali Toll Plaza for FY-2024-25 effective from 03.06.2024 (00:00:01 Hrs) upto 31.03.2025. - 3. The rate for monthly pass for local non-commercial vehicles residing within a distance 20 Km from the toll plaza for the FY 2024-25 shall be Rs.340.00 for each toll plaza.
- 4. This office vide letter dated 26.03.2024 has conveyed the revised user fee rates for FY 2024-2025, subsequent upon the direction of NHAI HQ vide letter dated 19.04.2024 has clarified that "the status quo in respect of User Fee rates prevalent for F.Y. 2023-24 (without revision) at National Highways Fee Plazas be continued till 01.06.2024, as presently General Elections for Parliament are under process and last date of poll is 01.06.2024."
- 5. Further, NHAI HQ vide letter dated 30.05.2024 has informed that "the revised User Fee rates for F.Y. 2024-25 for National Highway Fee Plazas shall be effective w.e.f. 03.06.2024 (00:00 Hrs.), in accordance with the applicable National Highways Fee Rules, after publication in newspapers as per Rule 12 mentioned above, only on 02.06.2024 and not before 02.06.2024 in compliance of ECI directions."
- 6. In view of above, it is to inform that NHAI HQ vide Policy Matter Technical:179/2015 dated 21.08.2015 has circulated approved standard format (Format-4) to be used by the Concessionaire while notifying revised user fee rates at toll plaza for publication in newspapers. Copies of newspapers wherein notices are published shall be submitted to this office for record purpose.
