In inviting a kind reference to the subject cited above, it is to state that, this office has calculated and submitted the Revised Toll Fee Rates, to be applicable w.e.f. 01.04.2025 to 31.03.2026 are as under:

Sub: Approval for revision of user fee rate of toll plazas (running under PIU Berhampur) under RO- Odisha jurisdiction w.e.f. 01.04.2025 (i.e. 3 numbers of toll plaza under PIU Berhampur) - Reg.

With reference the subject cited above, the proposals of revision of toll plaza rates w.e.f.01.04.2025 has received from PIU-Berhampur under the jurisdiction of RO-Odisha. Regional Officer has been delegated with the power for approve the proposal of validation (Initial fixation)/revision of user fee rates as per Policy No.17.6.9 Dt.13.03.2018 and Policy No.20.03.2018 of NHAI HQ New Delhi.

In this regard, this office has verified and checked the calculation of revised user fee rate of 3 no's of toll plaza running under PIU Berhampur and found in order.

The whole sale price index is taken for all commodities for the month of Dec'24 as 155.7 (copy enclosed, downloaded from office of the Economic

Advisor, Ministry of Commerce & Industry, Govt. Of India).

It is further to clarify that as per user fee notification, the concessionaire shall issue 50 or more one way tickets at a discounted rate equivalent to 2/3rd of the fee payable during the period of one month from the date of payment of fee. If any person asks more than 50 trips during a period of one month the concessionaire shall be required to issue such tickets at a discounted rate as above (i.e. If 60 trips are asked in a month by any person for a car the amount will be [60 x pre- rounded fee for single trip x 2/3 rounded to nearest 5]).

As per the delegation of power Regional Officer may approve the new user fee rate and communicate to the respective PIU Berhampur for implementation w.e.f. 01.04.2025 with wide publicity in newspapers.
