The approved revised user fee rates for above mentioned section to be applicable w.e.f 01.04.2025 to 31.03.2026 at Gudur Toll Plaza are as under:

- 2. The provisional fee rules as per the published fee notification vide reference 2nd cited, have been considered for revision of user fee for the year 2025-26.
- 3. PD, PIU, Warangal vide reference 3rd cited above, submitted the revision of user fee for the year 2025-26 as proposed by the Concessionaire and recommended by the IE.
- 4. Based on above PD's recommendation, the approval of Competent Authority for revision of user fee for the year 2025-26 of above mentioned section to be applicable w.e.f. 01.04.2025 to 31.03.2026 at Gudur Toll Plaza, is hereby communicated as under.

The above mentioned user fee rates for the year 2025-26 have been calculated in provisions of the 2008 Amended Fee Rules & based on the WPI for all commodities for Dec, 2024 stood at 155.7 and considering the linking factor 1.641 & 1.873 for converting WPI all commodities (2011-12) to WPI all commodities (2004-05) & based on the following details:

1. Length of Project Highway

35.65 Km

2. Four lane road other than by pass

22.90 Km

3. Ghatkesar Bypass

4.05Km with a cost of Rs. 68.75 Cr

4. Bhongir Bypass

8.70 Km with a cost of Rs.90.15 Cr.

- 6. The above approval is subject to the following conditions:
 - (i) PD will recheck the calculation before implementation. In case any discrepancy is found same shall be informed to this office for examination and issue amendment if any required.
 - (ii) PD will confirm after its implementation and forward a copy of advertisement issued by the Concessionaire for commencement of revised user fee to this office.
 - (iii) It is also brought out that MORTH vide letter dated 07.03.2019 has brought out and prescribed guidelines / standard Operating procedure (SoP) for Toll Notifications and mandatory ETC infrastructure in all toll lanes. Hence, the same shall be examined for its applicability wherever required.
- 7. As per user fee notification, the Concessionaire shall issue 50 or more one way tickets at a discounted rate equivalent to 2/3rd of the fee payable during the period of one month from the date of payment of fee. The amount indicated above for monthly pass for 50 trips. However, if any person asks more than 50 trips during a period of one month, the Toll Contractor shall be required to issue such tickets at a discounted rate as above and necessary action may please be taken accordingly.
- 8. It is further requested to verify the completed lengths / lengths handed over to Concessionaire vis-à-vis those considered in rates calculations and then send the approved rates to Concessionaire.
- 9. The rates for monthly passes applicable for local non-commercial vehicle residing within a distance of 20 Km from the above toll plaza for the year 2025-26 shall be Rs.350/subject to revision every year as per the provisions of the 2008 Amended Fee Rules.
- 10. Detailed calculation sheet is also enclosed herewith, so that, the above rates may be rechecked at your end before implementation. In case, any discrepancy is found, the same may immediately be informed to Regional office, NHAI, Hyderabad.
