

2. The rate of monthly pass for local non – commercial vehicles residing within a distance of 20 Km from the toll plaza for the FY 2016-17 shall be Rs. 235.00.
3. It is to clarify that as per user fee notification, the Concessionaire shall issue 50 or more one way tickets at a discounted rate equivalent to 2/3rd of the fee payable during the period of one month from the date of payment of fee. The amount indicated above is for monthly pass for 50 trips. However, if any person asks more than 50 trips during a period of one month, the concessionaire shall be required to issue such tickets at a discounted rate as above [i.e. if 60 trips are asked in a month by any person for a car at km 224.950 (near Gurau village), the amount is 60×54.48 (pre-rounded fee for single trip) $\times 2/3 = 2179.20$ i.e. rounded to Rs. 2180/-]. The detailed calculation sheet is also enclosed, to be rechecked at your end.
4. No user fee shall be levied for the delayed period between the Scheduled Date of Completion (910th day from the Appointed Date of 6-laning Project) and the date of actual completion of the project. For the purposes of this rule, any provisional completion of the project shall not be treated as completion of the project.
5. The detailed calculation sheets are also enclosed herewith, so that, the above rates may be rechecked at your end before implementation.
6. Please confirm after its implementation and provide copy of advertisement for commencement of revised user fee.
