It is intimated that the Competent Authority, the Regional Office Chandigarh has approved the revised user fee rates to be applicable for the **Kalajhar toll plaza w.e.f. 01.04.2025** for the FY **2025-2026**; which are reproduced as hereunder:-

- The user of the vehicle not fitted with Fastag or vehicle without valid or functional Fastag entering into Fastag lane of the toll plaza shall pay a fee equivalent to two times of the fee applicable to that category of vehicles as per Notification no GSR298 dated 15.05.2020
- Rate of Monthly pass for a person who owns mechanical vehicle registered for non-commercial purpose and resides within a distance of twenty kilometers from the fee toll

2. It is intimated that the public notice regarding revised toll fee has processed for publication in the newspapers; hence, it is requested to ensure wide publicity of revised fee rates at Display Boards installed in toll plaza premises of Kalajhar Toll Plaza applicable w.e.f. 01.04.2025 and the same should be displayed prominently at toll plaza.
