With reference to above, it is to inform that Competent Authority has accorded the approval for revised toll fee rates for financial year 2024-25 w.e.f. 01.04.2024 for Lacchiwala Fee Plaza. The category wise details of User fee are as under:

2. The rates of monthly pass for local non-commercial vehicles residing within a distance of 20 Km. from the toll Plaza for the F.Y. 2024-25 w.e.f. 01.04.2024 shall be Rs.340/- (Rupees Three Hundred Forty Only).

3. Further, as per clause 5 of CA, Contractor (Tolling Agency) has to submit proposal to authority for revised remittance. Hence, it is therefore, requested to submit the proposal for revised remittance alongwith calculation within 02 days positively.
