

Based on your recommendation, the approved user fee rates for above mentioned section to be applicable w.e.f. 01.04.2024 (0.00 Hrs.) for FY 2024-25 are as under:

Manderdisa Fee Plaza at Km. 62.400 on NH-27(New)/NH-54 (Old) for a road length of 54.110 Km, 6.160 Km length of Bypass and 1.130 Km length of completed structure in State of Assam (Under Fee Rules 2008 as Amended).
