Sir,

With reference to the above and on the recommendation of Project Director, NHAI, PIU Dhamtari, the Competent Authority, NHAI, RO Raipur has approved the revised user fee rates for Financial year 2022-23 applicable from 01.04.2022 to 31.03.2023 for Mashora Fee plaza. The approved revised user fee rates are as under:

2. The rate of monthly pass for a person who owns a mechanical vehicle registered for non-commercial purpose & resides within a distance of 20 Km. from the fee plaza for the FY 2022-23 shall be Rs.315/-.

3. Fee for commercial vehicle (excluding vehicles plying under National permit) registered in the district where the fee plaza falls shall be 50% of the specified rate for the category of vehicle provided no service road or alternative road is available for use of such commercial vehicles.

4. Further, Competent Authority, RO-Raipur has also approved revised daily remittance of Rs. 512,461/- (excluding TCS) for FY 2022-23, to be paid by existing tolling agency of Mashora Toll Plaza.

5. The above Rates shall be rechecked/confirmed at your end before implementation. In case any discrepancy is found at your level, the same shall be immediately informed to RO-Raipur.
