Please refer to above subject and references. In this context, it is intimated that the Competent Authority of NHAI has approved the revised rates of 'user fee' to be applicable from 01.04.2018 for the year 2018-19 as under:

Rate of monthly pass for a person who owns a mechanical vehicle registered for noncommercial purposes and resides within a distance of twenty kilometers from the toll plaza is Rs. 255.00 (Rupees Two Hundred and Fifty Five only) for the year 2018-19.

3. For the column vide which the Fee for monthly pass is conveyed, it is clarified that as per 'Clause 27.5.2 of Concession Agreement, the Concessionaire shall issue 50 or more one way tickets at a discounted rate equivalent to 2/3rd of the fee payable during the period of one month from the date of payment of fee. The amount indicated above for monthly pass is for 50 trips. However, if any person asks pass for more than 50 trips during a period of one month, the Concessionaire shall be required to issue such tickets at a discounted rate as above, i.e. if 60 trips are asked in a month by any person for a car, the amount is 60x.Rs. $50.34 \times 2/3 = Rs.2013.60/-$ , rounded to nearest Rs. 5/-, i.e. Rs.2015/-.Necessary action may please be taken accordingly.

4. It is requested to take action for wide publicity of revised fee rate before its implementation Copy of calculation sheet is also enclosed for verification and informing the discrepancy if any.
