Rate of Monthly pass for a person who owns mechanical vehicle registered for non-commercial purpose and resides within a distance of twenty kilometers from the fee toll plaza is Rs. 350/- (Rupees Three Hundred and Fifty only) / per calendar month for the year 2025-2026 and subject to revision every year as per the provisions of the National Highways Fee (Determination of Rates and collection) Rule, 2008.
