"CHANGE IN THE RATE OF USER FEE: b) The revised remittance on annual increase of user fee rate due to change in WPI, will be determined using the weighted percentage increase in the rates of all categories of vehicles, using proportions of different categories of vehicles\* and considering single journey rates. A sample calculation is given in Schedule- VIII.

The Authority will inform the proportion (%) of contribution in APC of different categories of vehicles in clause-1.1.3 of RFP".

4. It is requested to submit revised remittance calculation based on revised rates of user fee as per Clause 5 of Contract Agreement and implement revised rates w.e.f. 01.04.2024 after giving wide Publicity.
