

Bus or Truck (Two Axles)	280	420	9305	140
Three-axle commercial vehicles	305	455	10150	150
HCM or EME or MAV (four to six)	440	655	14590	220
Oversized Vehicles (seven or more axles)	535	800	17765	265

2. The rate for monthly pass applicable for local non-commercial vehicles residing within a distance of 20 Km from the Fee Plaza for the year 2024-25 shall be Rs. 340/-.
