With reference to subject cited matter, it is intimated that the Competent Authority of NHAI has approved the revised user fee rates for the year 2024-25 to be implemented w.e.f. 01.04.2024.

2. The revised user fee rates of Dighal Toll Plaza are as under:

3. The rate of monthly pass for a person who owns a mechanical vehicle registered for non-commercial purpose and resides within a distance of twenty kilometers from the toll plaza is Rs. 340.00/- (Rupees Three Hundred Forty only) for year 2024-25 and is subject to revision every year as per the provision of National Highways Fee (Determination of Rates and Collection) Rules, 2008.

4. In view of the above, it is directed to take necessary action for implementation of the said revised user fee rates w.e.f. 01.04.2024 and do needful for wide publicity of revised user fee rates before its implementation.
