Sub:- Four laning of Bhiwani-Mandola (Charkhi Dadri) section of NH-148 B from km. 94+600 to km. 125+920 (Pkg-IV) on EPC mode in the State of Haryana- Revision of user fee rates at Kitlana Fee Plaza w.e.f. 01.04.2024 for FY 2024-25-Reg.

With reference to subject cited matter, it is intimated that the Competent Authority of NHAI has approved the revised user fee rates for the year 2024-25 to be implemented w.e.f. 01.04.2024.

2. The revised user fee rates of Kitlana Fee Plaza are as under:

3. The rate of monthly pass for a person who owns a mechanical vehicle registered for non-commercial purpose and resides within a distance of twenty kilometers from the toll plaza is Rs. 340.00/- (Rupees Three Hundred Forty only) for each fee plaza for the year 2024-25 and is subject to revision every year as per the provision of National Highways Fee (Determination of Rates and Collection) Rules, 2008.
