Engagement of user fee collection agency on the basis of Competitive Bidding (on e-quotation basis) for Makrauli Kalan at Km. 9.800 on Rohtak-Panipat section from km. 0.000 to km. 80.858 of NH-709 (Old NH-71A) in the State of Haryana-Revision of user fee rates at Makrauli Kalan Fee Plaza w.e.f. 01.04.2024 for FY 2024-25-Reg.

With reference to subject cited matter, it is intimated that the Competent Authority of NHAI has approved revised the user fee rates for the year 2024-25 to be implemented w.e.f. 01.04.2024.

2. The revised user fee rates of Makrauli Kalan Fee Plaza are as under:

The rate of monthly pass for a person who owns a mechanical vehicle registered for noncommercial purpose and resides within a distance of twenty kilometers from the toll plaza is Rs. 340.00/- (Rupees Three Hundred Forty only) for each fee plaza for the year 2024-25 and is subject to revision every year as per the provision of National Highways Fee (Determination of Rates and Collection) Rules, 2008.
