With reference to the above cited subject, your office has submitted the letter to this office regarding Proposal for Revision of Toll Fee Rates with effect from 01.04.2023 in pursuant to Schedule 'R' of Concession Agreement vide ref. at (iii) above.

- Independent Engineer of project has scrutinized and recommended the proposal for Revision of Toll Fee Rates with effect from 01.04.2023 to this office vide ref. at (iv) above.
