Sub: Revision of user fee rate for FY 2020-21 at Semri Toll Plaza at Km. 140.400 & Ait Toll Plaza at Km. 187.500 of NH-25 under OMT Package, the Stretch from Km.90.300 to Km.225.713 in the State of Uttar Pradesh - Reg.

PUC is the proposal for validation of user fee rate submitted by PD, PIU-Jhansi vide letter no. 1586 dated 20.03.2020 and email dated 24.03.2020 for Fee Plaza at Semri Toll Plaza at Km. 140.400 & Ait Toll Plaza at Km. 187.500 on NH-25 in the state of Uttar Pradesh.

In this regard following points are made:

- 1. Base rates (2007-08) are taken from Fee Rule 2008.
- 2. As per Fee Rule 2008, rates are to be increased at the rate of 3% per year and such increased rate shall be deemed to be the base rate for the subsequent year. Therefore, increment is taken as (13* 3= 39%) for FY- 2020-21.
- 3. WPI for Dec, 2019 is calculated by taking 123.0 for base year 2011-12 as per office of the economic advisor website published on 16.03.2020 and NHAI Policy No 18.30 dated 20.03.18. Linking factor will be taken as 1.873 for base year 2004-05 and for FY- 16-17 linking factor is 1.641 as per Policy dated 20.03.18. Therefore, calculation comes as (123.0* 1.873* 1.641= 378.0519).
- 4. As per Fee Rule 2008, such revision shall be restricted to forty percent (40%) of the increase in wholesale price index.
- 5. As per PD,PIU Kanpur letter no. 1586 toll notification dated 09.09.2016, net road length without structure (excluding length of bypass, if any) for Semri Fee Plaza at Km. 140.400 is 36.357 Km. and converted equivalent road length for structure is 3.886. Thus, tollable length for Semri Fee Plaza at Km. 140.400 is 40.243 Km. Further, net road length without structure (excluding length of bypass, if any) for Ait Toll Plaza at Km. 187.500 is 37.879 Km and Bridge length is 0.093 Km. Therefore, converted equivalent road length for structure for Ait Toll Plaza at Km 187.500 is 0.930 Km. Thus, tollable length for Ait Toll Plaza at Km. 187.500 is 38.809 Km.
- 6. In view of above points, following rates are calculated for FY- 2020-21 as under:
