- 2. Rate of monthly pass for a person who owns a mechanical vehicle registered for non-commercial purposes and resides within a distance of twenty kilometers from the toll plaza is Rs. 245.00 (Rupees Two Hundred Forty Five only) for the year 2017-18.
- 3. For the column vide which the Fee for monthly pass is conveyed, it is clarified that as per Clause 27.5.2 of Concession Agreement, the Concessionaire shall issue 50 or more one way tickets at a discounted rate equivalent to 2/3rd of the fee payable during the period of one month from the date of payment of fee. The amount indicated above for monthly pass is for 50 trips. However, if any person asks pass for more than 50 trips during a period of one month, the Concessionaire shall be required to issue such tickets at a discounted rate as above, i.e. if 60 trips are asked in a month by any person for a car, the amount is 60xRs.96.25 x2÷3= Rs.3850/-, rounded to nearest Rs. 5/-, i.e. Rs.3850/-.Necessary action may please be taken accordingly. Copy of calculation sheet is also enclosed for verification and informing the discrepancy if any.
- 4. Please ensure that the above approved user fee rates may be conveyed to the Concessionaire only after completed length considered in the calculation of user fee rates (calculations enclosed) matches with the completed length as per CA/Fee Notification.
