Subject: Instructions regarding revision of User Fee Rates at NH Fee Plazas w.e.f. 01.04.2024 - reg. Ref.: Efile no. NHAI/13013/CO/23-24/UserFeeRevision (Computer No. 245361) dated 01.04.2024 Sir.

A reference was made to the Election Commission of India (ECI) on annual revision of user fee rates due on 01.04.2024 in view of the provisions of the Model Code of Conduct enforced during General Elections 2024. In this regard, ECI has clarified in its letter dated 01.04.2024 that the User Fee may be seen in context of the power tariff as mentioned in the sub paragraph-20 of paragraph-II of the Commission's instructions issued vide letter dated 02.01.2024.

- 2. Accordingly, it has been decided to maintain status quo in respect of User Fee Rates i.e. to continue with the User Fee Rates prevalent for F.Y.2023-24 (without revision) at National Highways fee plazas till date of poll.
- 3. Any claim of BOT/OMT/TOT/InVIT Concessionaires in this regard will be addressed in accordance with the relevant provisions of respective Concession Agreements.
