2. Approval of Competent Authority i.e. CGM(T) / RO-Nagpur is herewith conveyed for the following revised rates of User Fee to be made applicable from 01.04.2024 for the year 2024-25 at:

A. Shirpur Toll Plaza at km 205+000:



3. Rate of monthly pass for at Shirpur & Songir toll plaza, for a person who owns a mechanical vehicle registered for non-commercial purposes and resides within a distance of twenty kilometre form the toll plaza is **Rs. 340.00** (Rupees Three Hundred Forty only) for the year 2024-25.
4. As per Clause 27.5.2 of Concession Agreement, the Concessionaire shall provide discount in 'user Fee rate equivalent' to 2/3rd of the fee payable during the period of one month from the date of payment of fee. The amount indicated above for monthly pass is for 50 trips. However, if any person asks pass for more than 50 trips during a period of one month, the Concessionaire shall be required to issue such tickets at the discounted rate as per Para 3 above.
5. It is requested to take action for wide publicity of revised fee rates before its implementation.
